Peabody Awards Consideration Release

The undersigned entrant company/organization ("Entrant") is submitting the program described in the application to which this Release is attached. In exchange for the opportunity for Entrant's program to be considered for a Peabody Award, the undersigned Entrant hereby grants the Board of Regents of the University System of Georgia, by and on behalf of the University of Georgia Peabody Awards ("Peabody Organization") a non-exclusive right and license to use the materials constituting the program described in this application and other materials provided by or on behalf of Entrant in connection with its entry, including other materials submitted in response to subsequent requests from the Peabody Organization for materials in connection with Entrant's project and entry (collectively, the "Submission"), for the following purposes and in all platforms and in all media now known or hereafter devised (collectively, the "Permitted Uses"):

- Peabody Awards judging (including via password protected streaming);
- permanent storage in the Peabody Awards Collection archive; and
- use of images or video materials from the Submission in the Peabody Awards Ceremony, annual Peabody Awards Presentation and Announcements, Peabody Awards Show (including the production and distribution thereof), and otherwise in furtherance of the Peabody Organization's Mission, and in the advertising and promotion of any of the foregoing.

Entrant acknowledges that the Submission may be evaluated by judges in different locations, and the license provided hereunder shall include the right to distribute the Submission to the judges wherever located solely for the purpose of evaluating the Submission. In the event that Entrant's Submission is selected as an award nominee or winner, Entrant acknowledges that a full copy (or representation) of the project will be requested for permanent storage in the Peabody Awards Collection Archive, and Entrant agrees to provide the Peabody Organization additional information reasonably necessary to maintain archival footage or to capture the Submission's function as designed and in the same manner as the Submission was evaluated during Peabody Awards judging. The Peabody Organization is under no obligation to use the Submission for any of the Permitted Uses. Nothing herein shall limit the Peabody Organization's rights as a member of the general public.

As used herein the "Peabody Organization's Mission" means the educational purposes of invigorating people through the transformative power of stories that matter, that engage viewers as citizens, and that teach, expand our horizons, defend the public interest, or encourage empathy with others. The Peabody Organization's Mission is pursued via publicity and outreach activities such as press releases, video news conferences, lectures, webcasts, panels, podcasts, touring exhibitions, and social media.

Entrant represents and warrants that it has the right and authority to grant the rights granted hereunder, that the consent of no other person or entity is required to enable use of the Submission as described herein, and that such use will not violate the rights of any third party. Entrant waives all rights to legal recourse regarding use of the Submission, including likenesses therein. Entrant agrees to take responsibility for any and all claims arising out of use of the Submission as authorized herein. The rights granted herein shall inure to the benefit of the Peabody Organization, its licensees, successors, and assigns.

This Release constitutes the entire agreement and understanding between the parties regarding this subject matter hereof. Any additional terms or conditions submitted by the Entrant shall be void. The undersigned confirms that he/she has read and fully understood this document, and has not signed it in reliance on any statement or representation by the Peabody Organization or anyone acting on its behalf.

Files must be uploaded **individually and chronologically** in the order that episodes aired (earliest air date should be first).

When your video upload says "Processing," press "Save" at the bottom of the page, and you will be able to move on to the next video. Wait until you see the "Processing" message before proceeding to the next video file upload.

DO NOT LOSE YOUR WORK: Do not open multiple tabs in your browser or use different browsers to upload multiple files at the same time. Doing so will result in lost and unrecoverable work.

For news programming and radio/podcasts, please submit a photo representative of the story. If the program is selected as a nominee or winner, Peabody may request additional photos.
